6. In the event of a default in payment, the customer will pay attorney's fees and court costs incident to any formal collection proceedings that may be required.

8. In consideration of Muskoka Rent All extending credit to a corporation or proprietorship, I hereby personally guarantee the indebtedness of the corporation or proprietorship to Muskoka Rent All.
